SLT and Partners to Build Spring Hill Trail

Great news! The Siskiyou Land Trust just signed a Memorandum of Understanding to move forward with planning for a new public trail proposed for the Spring Hill property that is owned by the Coca-Cola Bottling Plant. It would be an easy hike for all ages and a significant addition to the urban trails in Mt. Shasta. There are excellent views as you hike up the hill and at the top there is a panoramic view of all the mountains in this area. It would offer a great way to spend a few hours in an afternoon, and would likely be popular with summer visitors.

Completing the Spring Hill Trail will be a cooperative effort between the Siskiyou Land Trust, the Mt. Shasta Trail Association and the landowner Coca-Cola. Over the past year the two nonprofits have had a series of discussions with the management of the Bottling Plant about establishing a hiking trail on this property. Two weeks ago John Brennan (Siskiyou Land Trust President), Steve Horn (Siskiyou Land Trust Executive Director) and Joe Wirth (Mt. Shasta Trail Association President) met with Tim Fischbach (newly appointed Bottling Plant Manager) and signed the Memorandum of Understanding to proceed with the planning phase of the project.

The next steps are for the Land Trust and the Trail Association to develop a detailed design of the improvements needed to create a safe trail, to resolve issues of insurance and long-term trail management, and to submit our plan to Coca-Cola for consideration. Ultimately, we hope to connect the trail to the Mt. Shasta City Park across North Mt. Shasta Boulevard.

We'll be keeping you informed about this exciting new chance to enjoy our natural beauty, and SLT members can expect that we'll be calling on you to help "dig in" with some of the landscape cleanup, fencing and other improvements. We'll need your help to make this come true.

Letter from the President Spring greetings to all you great community folks who so generously support our work. What have we done with your help?

At Sisson Meadow, we've installed parking space along the Castle Street alley for use by visitors, and our volunteers have worked to maintain and upgrade the property so all can enjoy it.

We conducted a bird-watching trip up to the Klamath Wildlife Refuge, and guided hikes to Southgate Meadow on Mt. Shasta and to Stafford Lakes, for the enjoyment of Land Trust members and the community. Volunteers led those excursions.

We've spent a lot of time sitting around the kitchen tables of farming families in the Scott River and Shasta River valleys, talking about how to keep agriculture as a vital part of the future of Siskiyou County. Large ranches provide critical wildlife habitat, as well as providing a beautiful landscape that we all enjoy every day. Member contributions make this possible.

In partnership with the Mt. Shasta Trail Association we've worked out an agreement with the Coca Cola Bottling Company, and with your help we'll build a trail up Spring Hill that is sure to be a big hit with visitors.

We work hard to preserve agricultural, forest and wildlands. Plain and simple, volunteer efforts make these successes possible - - they just wouldn't occur without financial and physical support from our community. The land trust Board is committed to generating continuing benefits which repay our members and show our respect and appreciation for all you do.

SLT Proposes First County Agricultural Easement

The Siskiyou Land Trust has agreed with Scott Valley ranchers to protect 5,500 acres of rangeland and cultivated agriculture along the Scott River near Etna. The Plank and Whipple families manage several adjacent ranches. These families are protective of the natural landscape in their current farming practices, and they believe in Siskiyou County for long-term agricultural productivity. The Land Trust and the landowners are working together to bulwark these working farms through a conservation easement that would avoid future subdivision of the properties or conversion of them to nonagricultural uses.

The Land Trust is seeking financial assistance from public and private sources for the purchase of these conservation easements. The Siskiyou County Board of Supervisors has voted to support these efforts, indicative of a broad consensus on the importance of these open space lands to the future of the County.

The conservation easement will protect productive rangeland and cropland, provide "back country" wildlife habitat for bears, mountain lions, elk and deer herds, and will maintain the historical scenic views of the Scott River farmlands and the hills that frame them. The Plank and Whipple ranches take in more than 1½ miles of the Scott River, a crucial part of the Klamath River system that is home to the endangered coho salmon, and agricultural practices here are respectful of the riparian habitat.

This project would be the first conservation easement to protect working farmlands in Siskiyou County. The Land Trust Board regards this as a very significant (and exciting!) breakthrough for conservation planning and resource protection. Stay tuned for updates on our success in completing this project!
